Key results – Benchmarking

This report provides a summary of health and safety performance for Business Leaders' Health and Safety Forum members participating in the benchmarking initiative. This initiative helps members understand and compare their performance, and helps track progress towards the Forum's goals.

Tragically six workers lost their lives during this period.

The results show an overall 2022 Total Recordable Injury Frequency Rate of 3.58 (employees and contractors). This was a 23.56% decrease on the 2021 result.

The Near Miss Reports have decreased by nearly 35% in 2022 compared with 2021. In theory these should be high if a business has a mature culture and good reporting systems. Less mature companies often don't record them either because they don't have the systems in place, or their teams are not talking about them.

In 2022, 71 members took part in benchmarking, compared with 80 in 2021. The hours worked (sample size) was 205 million hours worked for employees and 49 million hours worked for contractors.

This initiative uses OSHA definitions for injuries, and all frequency rates are based on 200,000 hours worked.

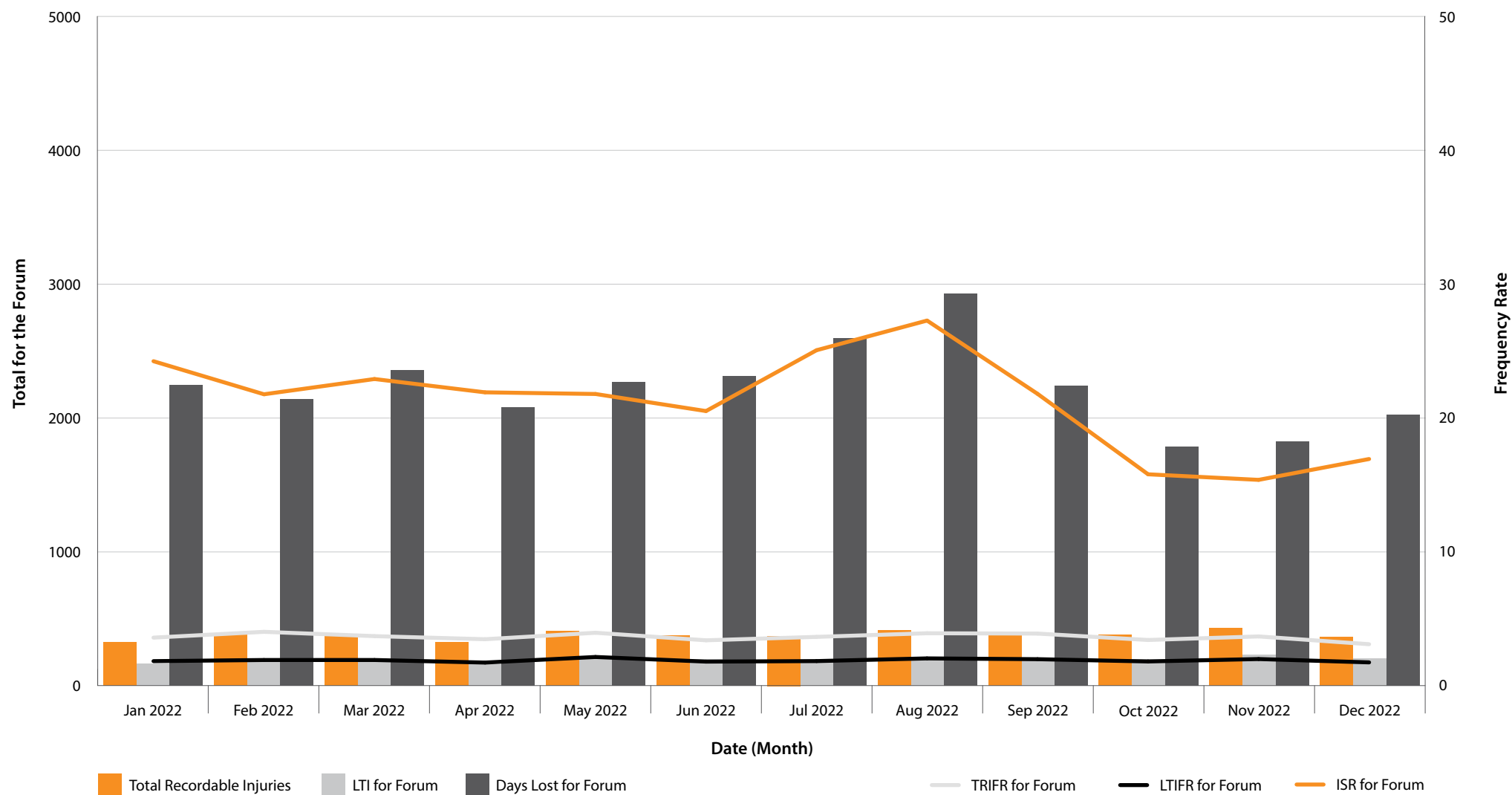

About the data

This report may not necessarily reflect the level of risk of serious or fatal harm within participating businesses.

All frequency rates are based on 200,000 hours worked.

The data in this report may be subject to errors relating to the way it is collected, classified and reported by member organisations and with the collation of results. In particular, data quality is impacted due to the fact that some Forum members do not populate all measures, alter data after the summary report is published or apply the OSHA definitions differently for reporting injury outcomes.

The Forum adopted a common injury reporting standard (OSHA) and injury classification standard (based on ANZSIC level 1) in December 2011 to improve the quality and reliability of benchmarking data.

Definitions

- **Restricted work injury:** Where an injury prevents a return to work on normal duties for 1 day/shift or more.
- **Lost time injury:** Where an injury prevents a return to work for 1 day/shift or more.
- **Medical treatment injury:** Any significant work-related injury or illness diagnosed by a physician or other licensed health care professional. Includes managing and caring for a patient to combat a disease or disorder.
- **Total recordable injury:** Total medical treatment injuries, restricted work injuries, lost time injuries and fatal injuries.
- **First aid injury:** An injury requiring minor treatment.
- **All injuries:** Total recordable injuries plus first aid injuries.
- **Frequency rates** based on 200,000 hours worked.
